

s part of my pledge to represent your views in Parliament, I regularly consult with you on important issues through my community mailings and online surveys.

A mail-in survey was sent to all households asking what issues you would like to see Parliament focus on more and what issues you would like to see Parliament focus on less.

This feedback, along with the hundreds of letters and thousands of emails, helps me to better represent the community — even if it is not always in line with my party's position.

The top five issues the community wants Parliament to <u>focus on more</u> are:

- Getting Pipelines Built (56%)
- Reduce Gov't Spending (48%)
- Cost-of-living Issues (46%)
- Spending More On Healthcare (41%)
- Cutting Personal Taxes (29%)

On the other hand, the five issues the community wants Parliament to <u>focus</u> <u>on less</u> are:

- Increasing Immigration (50%)
- Indigenous Reconciliation (50%)

- Firearms Restrictions (48%)
- Universal Basic Income (41%)
- The Environment (34%)

It was clear that there was a stark polarization of political views on a number of issues, but when the results are combined, a consensus seem to form around a few issues with Cost-of-Living Issues, Getting Pipelines Built, Spending More On Healthcare, Reduce Government Spending and Reopening The Economy being the most important; and Increasing Immigration, Indigenous Reconciliation, Firearms Restrictions, Universal Basic Income and Animal Welfare being the least important.

Thank you to everyone who participated. Your participation greatly influences how you are represented in Parliament.





### 2022 Community Survey Results

A copy of this survey was mailed to every household in the Calgary Confederation riding and the results are accurate to within +/-3.02% 19 times out of 20.

It is worth noting that with this margin of error many of the issues are considered to be statistically tied.

### **HOW WOULD YOU VOTE?**

Since 2016, the United States government has been sharing travel information on convicted sex offenders that plan to travel to Canada.

In the first half of this year alone, 165 US citizens were flagged to Canadian officials and 112 of them were denied entry into Canada.

Understandably, the American government has been looking to Canada for six years to reciprocate by sharing information on Canadian sex offenders who are planning on travelling to (or through) the United States.

Canada already collects this information — Canadians on the *National Sex Offender Registry* must notify police seven days in advance of their intention to travel internationally.

Canadian law currently prevents the sharing of information on the 59,069 convicted sex offenders with another country unless it is believed that an offence is going to be committed.

As a result, Canada has only provided one name in the first half of this year to the Americans and, not surprisingly, that person was denied entry to the United States.

The Liberal government says it is looking to give "greater flexibility" to provide information to the

Americans and other nations about the travel of Canadians listed on the *National Sex Offender Registry*.

The Liberal government cites concerns about protecting the privacy of convicted sex offenders and possibly breaching the *Privacy Act*.

Almost a dozen other countries share this type of information with the United States, but many countries in Europe do not — also citing concerns about privacy.

According to the Liberal Public Safety Minister, the Liberal government wants to "move quickly on this file", but have failed to bring the necessary legislation forward in the past six years.

While it is important that the federal government protect the privacy of Canadians, and adhere to the protections in the *Privacy Act*, I suspect most Canadians would want all governments to do what they reasonably can to prevent these people from re-offending at home or abroad.

If the Liberal government ever does bring forward legislation on this issue, all Parliamentarians will need to decide if it is reasonable to reduce certain privacy protections for convicted Canadian sex offenders or not. How would you vote?
