Through a petition to Parliament, I raised national awareness about a serious threat facing many Seniors.

Canadians are concerned that people with a history of sexually inappropriate behaviours are permitted to live in close quarters with vulnerable Seniors in care homes.

The petition cited the tragic case of a Calgary Alzheimer's patient, Ruth, whose sex assault could've been prevented if care homes took these threats more seriously.

The inability to separate known sexual abusers from very vulnerable populations is allowing them to commit their crimes with little recourse. This violates the vulnerable and causes untold stress and anxiety for their families.

It's time the Liberal government table legislation to prevent known sex offenders from cohabitating in facilities with known vulnerable Seniors.

Giant Axonal neuropathy which is a rare childhood genetic terminal disorder that affects the nervous system. There are 73 cases of GAN in the world. Two of those cases are in Alberta, one of these is our grandson, Julian.

There are international pilot projects that could offer unique research therapies for this and other genetic conditions, but we lack ability to seamlessly coordinate such projects.

One of the symptoms that led to the

diagnosis of GAN was Julian's tight curled hair. This marker, is so obvious in this disorder, sparked an initiative called Hannah's Hope

which calls for May 2nd to be "Curly Hair Day"

To support these children and their families fight for a cure I encourage you to think about them every "Second" of May!

SUPPORTING UKRAINE

Our community also held a candle-light Vigil under the Pysanka this year to recognize 354 days since the war began in Ukraine. We will always support Ukrainians in Lakeland and across Canada, and for the territorial sovereignty of Ukraine and their right to live peacefully and securely.

FIGHTING RURAL CRIME

REPEALING THE ESCALATOR

Under this government, basic pleasures like sharing a bottle wine with a loved one or enjoying a beer with friends have become increasingly unaffordable.

Last year I tabled Bill C-266 to repeal the automatic annual tax increase on beer wine and spirits. While my bill has not yet passed, and the automatic escalator remains in place, sustained pressure on the Liberals forced them to reduce what would have been an automatic 6.3% tax increase, to only 2%.

The automatic tax escalator still needs to be repealed so that future governments have to ask Parliament before increasing the tax on beer wine and spirits, and Conservatives will continue to stand up for producers, consumers, and Parliamentary accountability, until Bill C-266 is fully implemented.

SUPPORTING JUROR MENTAL HEALTH

I'm very pleased that Bill S-206, the Juror Mental Health Bill, of which I was the House of Commons sponsor, has now become law.

Jury duty can come at significant personal sacrifice. Jurors are often exposed to horrific evidence that can cause long-lasting mental health issues, including PTSD.

Since 2018, I worked across party lines to amend the Criminal Code so that former jurors experiencing mental health issues can disclose all as-

pects of their jury service with a mental health professional bound by confidentiality.

Prior to S-206, it was a Criminal Code offence for a former juror to disclose any aspect of the deliberation process, even to a mental health professional.

This small but important legislative change will go a long way to support the mental health of former jurors.

HELPING FAMILIES WITH INFLATION

Liberal inflationary spending and carbon tax hikes have resulted in skyrocketing food prices meaning Albertans struggle to feed their families. Grocery prices in Alberta have risen by 10.8%, one of the highest grocery inflation rates in Canada. As a result, according to Food Banks Canada, the use of food banks has increased by over 15%.

I, along with my Conservative colleagues, have taken concrete steps to help address rising food prices for Alberta families including

fighting for an exemption to the carbon tax on farm fuels (Bill C-234), forcing the Liberals to freeze the increase on the escalator tax and to abandon their expensive and non-sensical front of pack warning labelling on ground beef and pork.

WELCOMING THOSE FLEEING WAR

Since the start of the Russian Federation's unprovoked invasion of Ukraine, Canada has welcomed over 150,000 Ukrainians fleeing the war through the CUAET visa program.

Spring in Ukraine has brought renewed intensive fighting as ground operations resume on both sides, increasing the displacement of civilians near the combat zones.

In March, Conservatives called on the Liberal government to extend the CUAET visa program for Ukrainians

fleeing the war. Just days before CUAET expired, the Liberal government extended the program to July 15, 2023 for new applications.

It was only after Conservatives demanded an extension that we got it. Ukrainians displaced by war count on these temporary 3-year visas. Polls show that 72% wish to return to Ukraine once the war ends.

DISABILITY INCLUSIVE EDUCATION

That, where the federal government spends money on education, domestically or internationally, clear consideration must be given to the maximum inclusion of people with disabilities, including people with intellectual and developmental disabilities.

In low- and middle-income countries, approximately 50% of

children with disabilities are estimated to be out of school.

A recent UNICEF report found that, globally, children with disabilities were 49% more likely to have never attended school.

This motion is supported by *Inclusion Canada, Special Olympics, Pediatric Chairs of Canada, Indigenous Disability Canada, Easter Seals* and countless others across the country.

PROTECTING ACCESS TO MARKETS

YES, PM, THERE IS A CASE FOR LNG

Last August, Prime Minister Trudeau remarkably stated “there has never been a strong business case” for Liquefied Natural Gas (LNG) exports from Canada to Europe. He was responding to requests from German Chancellor Olaf Scholz for help with Europe’s energy crisis.

Bernard Shaw famously said, “People who say it cannot be done should not interrupt those who are doing it.” Tourmaline Oil is doing it. Proving the Prime Minister wrong, Tourmaline began exporting Canadian natural

gas to the U.S. Gulf Coast in January, for onward export to Europe and Asia. Tourmaline will double gas exports in the next three years.

This is the first significant volume of Canadian gas to be exported beyond North America and overcomes the price discount the Canadian product has struggled with. Step aside, Mr. Trudeau. Canadian entrepreneurs are getting it done.

FIGHTING POLITICAL DISCRIMINATION

EMERGENCIES ACT REVIEW COMMITTEE

After more than a year of study, the Special Joint Committee on the Declaration of Emergency is compiling the evidence that it has heard, developing recommendations, and preparing a final report. It is anticipated this should be completed and presented to Parliament before the end of June 2023.

Throughout the many hours of witness testimony and thousands of pages of documents, the committee did not receive any evidence that the government met the extremely high

threshold necessary in law for the invocation of the Emergencies Act.

The Government states they relied on a 'broader interpretation' of the threshold but has failed to make that legal opinion public. As we move forward, Conservative members will be providing recommendations intended to ensure that the Emergencies Act can never again be used in the same manner as it was for the Freedom Convoy.
